#### Call to Order

The public board meeting was called to order at 4:31 p.m. MST by Katharine Conover-Keller, Chair. Ms. Conover-Keller confirmed the Board of Trustees quorum.

### Approval of Agenda

Ms. Conover-Keller presented for approval the agenda of the March 6<sup>th</sup> Special Meeting of the Board.

It was moved by Dr. Pam Cutler, seconded by Jim Hunt, to approve the Agenda of the Special Meeting of the Board as presented. Members voted as follows: four Aves. The motion carried unanimously.

## **Comments from the Chair** (presented by Ms. Katharine Conover-Keller)

Ms. Conover-Keller recalled at last week's meeting that she proposed a slate of Board Chairs for each Committee as follows:

Cynthia Hogan as Nominating and Governance Committee Chair Evan Jones for Strategy and HR Committee Chair Jim Hunt for Finance, Facilities, and IT Committee Chair Dr. Pam Cutler for Joint Compliance and Quality Committee Chair.

It was moved by Jim Hunt, seconded by Evan Jones, to approve Ms. Conover-Keller's proposed slate mentioned above. The Board discussed. Members voted as follows: five Ayes, The motion carried unanimously.

Ms. Conover-Keller mentioned that although there is nothing in our SJH Board Bylaws that mandates a Trustee to only serve on one committee, serving on multiple committees is not advised due to the time commitment and workload that chairing each committee requires.

Ms. Conover-Keller addressed the need to vote for a Treasurer as Scott Gibson resigned, leaving the role open. Katharine nominated Jim Hunt, Chair of Finance, Facilities, and IT Committee to also serve as Treasurer to the Board of Trustees. <u>It was moved by Evan Jones, seconded by Dr. Pam Cutler to approve Jim Hunt as Treasurer to the Board of Trustees. Members voted as follows: five Ayes. The motion carried unanimously.</u>

Ms. Conover-Keller reviewed Trustee Committee Member assignments as follows:

Joint Compliance and Quality Committee (JCQC): Meets every other month. Trustees= Chair- Dr. Pam Cutler, Katharine Conover-Keller, Bruce Hayes

Trustees=Chair, Evan Jones, Pam Cutler, Katharine Conover-Keller

Nominating & Governance Committee: Meets alternate months from JCQC.

Trustees= Chair, Cynthia Hogan, Dr. Bruce Hayse, Dr. Brent Blue

It was moved by Jim Hunt, seconded by Dr. Pam Cutler to approve the three Trustees that would serve within each Committee proposed above. Members voted as follows: five Ayes. The motion carried unanimously.

Ms. Conover-Keller proposed members of the Special Litigation Committee as follows:

**Special Litigation Committee:** Meets as needed.

Trustees=Chair, Katharine Conover-Keller, Evan Jones, Dr. Pam Cutler

Advisors = Bob Pisano

Other Members = Legal counsel

It was moved by Jim Hunt, seconded by Dr. Pam Cutler to approve the Special Litigation Committee proposed above. Members voted as follows: five Ayes. The motion carried unanimously.

Ms. Conover-Keller noted that as Board Chair, she serves as a non-voting member on the SJH Foundation Board. The SJH Foundation Board allows for two Board of Trustees to serve as non-voting members. Ms. Conover-Keller proposed that Evan Jones serve as the second Foundation Board Member alongside her as the representative from the SJH Board of Trustees.

It was moved by Jim Hunt, seconded by Dr. Pam Cutler to approve Evan Jones to serve as a non-voting member on the SJH Foundation Board, which was proposed above. Members voted as follows: five Ayes. The motion carried unanimously.

Evan Jones and Katharine Conover-Keller discussed the 2023 Calendar and the Board informally reviewed and approved them. A copy of the calendar is attached.
